#### Decisions taken at the meeting

## CAB Decision 55/12 — Approval of the consent agenda items

CAB, by consent, noted and approved the 42 documents listed in Annex A to this decision list as consent agenda documents, and expressed appreciation to all those concerned with their creation and submission.

## CAB Decision 55/13 — Approval of the agenda

The CAB approved the agenda contained in CAB2461B/DA with the modification that agenda Items 4.1.1.1 and 7.1.5 were moved from the consent agenda to the main agenda and one item was added under 9.1.

# CAB Decision 55/14 — Gratitude to IEC President

The CAB expressed its gratitude and appreciation to Mr Jo Cops, IEC President, for his presence at the CAB meeting and his interesting and informative address.

## CAB Decision 55/15 — CAB subgroups membership

The CAB, noting document CAB/2436C/INF appointed the new members identified therein to the respective subgroups.

## CAB Decision 55/16 — CAB new CA Service Funding

The CAB thanked the TF Convenor, Ms Joan Sterling, for the task force report in document CAB/2477/R, and noting the comments received in CAB/2477A/CC and the discussion during the meeting, agreed to treat the recommendation as follows:

A1: CAB approved the Phase II Operational Aspects of the IEC CA Designated Fund given in document CAB/2477/R.

CAB approved the immediate establishment of the CA Designated Fund, as previously approved in IB Decision 2023/18.

# CAB Decision 55/17 — TF AI – Artificial Intelligence

The CAB thanked the TF Convenor, Mr Shawn Paulsen, for the task force report in document CAB/2475/R, and noting the comments received in CAB/2475A/CC and the discussion during the meeting, agreed to treat the recommendation as follows:

- A1: CAB approved the establishment of an official liaison between ISO/IEC JTC 1, SC 42 and the CAB TF AI, to provide updates to each other of their respective work.
- A2: CAB approved the change in the TF AI ToR point a), to read as follows: To identify product sectors that currently, or may, in the near future, utilize Artificial Intelligence (AI) in products, processes, systems and services.

### CAB Decision 55/18 - IECRE report

The CAB thanked the IECRE Chair, Mr Alistair MacKinnon, for his written report (CAB/2467/R) and for his additional verbal report and presentation (CAB/2512/MTG).

#### CAB Decision 55/19 - IECRE PV rating system

The CAB thanked Thomas Sauer for his presentation, on behalf of the IECRE, noted the documents CAB/2468A/DC, CAB/2468B/CC and CAB/2472B/INF and provided substantive feedback concerning the proposed service. CAB recognized that this proposal was innovative with respect to typical work of the IEC CA services. CAB supported continued cautious exploration and required ongoing updates to assess progress. Additional information of interest to CAB will be requested.

### CAB Decision 55/26 — Risk Management Procedure

The CAB expressed its gratitude and appreciation to Mr Peter Pondillo and Raphaelle Haller for their interesting and informative report and presentation (CAB/2505/MTG).

### CAB Decision 55/27 — Update of CA Risk Management Grid (RMG)

In relation to the timetable for the updating of the IEC Risk Management Register (RMR), CAB tasked the CAB Secretariat with implementing the following timetable to update the CA RMG:

- 2024 December CAB subgroup meetings CAB WG 10 TF Risk Management to analyse and propose IEC RMR / CA RMG integration.
- Q1 2025 CAB consultation on CA RMG and IEC RMR / CA RMG integration.
- Q2 2025 CAB approval, by correspondence, of the IEC RMR / CA RMG integration.
- 2025 May CAB approved IEC RMR / CA RMG integration proposal sent to GRAC.

## CAB Decision 55/28 — Modification to proposed Treasurers Meetings ToR.

The CAB requested that the 4<sup>th</sup> bullet point in document TM/11/DC (indicated in the slide on page 16 of document CAB/2455/INF) be modified to read as follows:

"To raise potential points of attention from the IEC CA Systems. to the IEC's governance bodies"

#### CAB Decision 55/29 — Establishment of TF CASCO.

The CAB agreed to establish a taskforce (TF) to review the formal relationship between IEC CA and CASCO regarding participation, input and a full review of the CABPUB process.

A call for members and a convenor to the TF will be circulated by the CAB Secretariat.

### CAB Decision 55/30 — IEC TC 106 SAR System Validation PAS.

CAB expressed its gratitude and appreciation to Mr Mike Wood (senior vice Chair of TC 106) for his presentation (CAB/2516/MTG) and for raising this issue to CAB.

## CAB Decision 55/31 — IEC TC 106 SAR System Validation PAS.

The CAB noted the initial discussions between TC106 officers and Exec Secretaries and requested further discussion involving IECEE officers to explore any CA needs that may support the TC 106 community. It was requested that appropriate updates be provided in future IECEE reports to CAB.

### CAB Decision 55/32 - Establishment of TF LTS initiative

CAB agreed to establish a taskforce (TF) to develop a first IEC CA proposal, no later than 30<sup>th</sup> September 2024, related to IEC's long term sustainability initiative, as related to the initial proposal of IB TF 7 LTS (indicated on slide 9 of CAB/2515/MTG), for CAB approval. TF membership is to include the members of CAB (with the exception of the IEC Secretary-General), with the CAB Chair as convenor, IEC CA System Chairs Treasurers and any designated experts.
